APPLICATION FOR MEMBERSHIP AND ELECTRIC SERVICE

The undersigned (hereinafter called applicant) hereby applies for membership in and agrees to purchase all electric energy for the requirements of the premises for which this application is made from Central Alabama Electric Cooperative (hereinafter called Cooperative). If applicant currently holds a valid membership in the Cooperative, this application shall be considered as an application by the Member for additional service under a separate meter. Should the membership account become inactive at some future date, the active service account may be considered as a membership account.

Applicant agrees as follows:

1. To comply with, and be bound by the provisions of the Articles of Conversion, and Bylaws of the Cooperative, and the Policies, known as the Service Rules and Regulations, which may from time to time be adopted by the Cooperative.
2. To purchase electric service for the premises for which this application is made at rates currently in effect or as amended from time to time, provided, however, that a bill of no less than the facility charge or contracted minimum, plus applicable taxes, will be paid regardless of the number of kilowatt hours consumed.
3. To make payment of such membership, or appropriate fee, as required by the Cooperative's Bylaws, their amendments, and/or Service Rules and Regulations in respect to application for membership or additional service.
4. To make such deposit with Cooperative as may be required by the Cooperative's Service Rules and Regulations. Such deposits shall be interest bearing and any portion of said deposits not applied to payment of accounts due Cooperative may be refunded to the member in good standing after twelve (12) months of continuous service or upon termination of service.
5. To cause premises to be wired in accordance with wiring specifications approved by Cooperative. If the applicant's service location is located beyond the Cooperative's maximum distance for line extensions to existing or proposed facilities, to pay additional facility cost as specified in the Cooperative's Service Rules and Regulations. Applicant agrees to grant necessary easements and right-of-way for Cooperative's electric facilities over applicant's property, free of cost to the Cooperative.
6. That an appropriate amount not in excess of three dollars (\$3.00) of the amount accruing to applicant each year may be used for annual subscription to the magazine produced by the Alabama Rural Electric Association and shall be paid for applicant by the Cooperative so as to reduce such funds in the same manner as would any expense item of the Cooperative.
7. That the acceptance of this application by the Cooperative shall constitute an agreement between the applicant and the Cooperative.
8. That membership in the Cooperative is contingent upon acceptance by Cooperative's Board of Trustees.
9. To pay all costs of collecting or securing, or attempting to collect or secure, including a reasonable attorney's fee and all court costs whether the same be collected or secured by suit or otherwise in the event a default occurs.
